Additional Clauses

* \$850 CPA is achieved on the condition that an affiliate brings in 50 QFTDs within a calendar month and that the net average deposits are a minimum of 2.5 times the CPA commissions owed in that month. E.g. Based on 50 QFTDs: CPA owed for the month 50 QFTDs x \$650 = \$32,500. Total net deposits: \$81,250 minimum to trigger the \$10,000 bonus. Total monthly payment: \$32,500 + \$10,000 bonus = \$42,500. Total CPA: \$42,500 total CPA commission / 50 QFTDs = \$850 CPA.

* The monthly bonus is only applicable to affiliates whose monthly net deposits are a minimum of 2.5 times their monthly CPA commission total.
